# Summary

Our client is one of the largest multinational banks in Australia, providing financial services in Australia, New Zealand, India, and the UK. They were leveraging intelligent automation to improve operations and had great success in automating back-office processes. However, to automate their core processes, they wanted to identify and prioritize the right processes for optimization and/or automation opportunities.

The bank selected EdgeVerve's AssistEdge Discover to take a data-driven approach to process discovery and task mining. Using Discover, the bank created a powerful automation blueprint that improved the speed and accuracy of process discovery by 70 - 80%.



# Business Challenge

The bank had set up an Automation Centre of Excellence that had successfully automated several processes, as a part of its automation journey, for several months. However, as they moved from non-core to core-processes, they wanted a more streamlined approach to identify the right processes for automation.

Owing to the success of their automation journey across the non-core processes, they had generated significant interest from the business units. However, they did not have a scientific way to prioritise the requests and were only able to address the requests on a first come first serve basis.

The bank realized it needed a data-based approach to analyze its “as-is” processes and identify the best candidates for optimization/automation. They needed a process and task mining solution that could give them a clear view of what was happening in their end-to-end processes. This insight would help them pinpoint the most feasible processes for automation and amplify outcomes. However, given the sensitive nature of banking operations, it was imperative that the solution had robust data privacy and security.

The bank conducted a comprehensive assessment for over 10 months including pilots with multiple task mining solutions. The assessment results clearly demonstrated AssistEdge Discover’s superior capabilities and the client chose us as their preferred Enterprise Task Mining Solution. Two key factors that helped the client make this choice were our:

**Market-leading process discovery capabilities that deliver granular process insights to create powerful automation blueprints, and**

## Solution

The success of any automation relies on a comprehensive understanding of existing processes to choose and optimize the best-fit candidates for maximum ROI. A sub-optimal, complex, or broken process understanding will not yield expected outcomes with automation. Therefore, EdgeVerve’s approach to automation starts with process discovery and optimization.

We deployed AssistEdge Discover to discover the bank’s processes and capture granular insights of how the processes were executed currently. This was done using smart data capture, leveraging computer vision and key-stroke logs. This process data was mapped to create detailed, interactive maps highlighting variations in process executions, process inefficiencies, and compliance issues. These insights enabled ROI-driven process optimization strategies and supported the creation of automation blueprints and a prioritization matrix to identify the best candidates for process optimisation and/or automation. In addition, once a process was finalized, AssistEdge Discover generated easy-to-use process design documents.:
